#### UPDATE ON THE HUMAN RIGHTS CASE FOR FIRST NATIONS KIDS The Tribunal Issues Letter-Decision Approving \$23.4 Billion Compensation Package for First Nations Children, Youth and Families

On July 26, 2023, the Canadian Human Rights Tribunal issued a letter-decision finding that the revised Final Settlement Agreement (FSA) signed by the Assembly of First Nations (AFN), the Caring Society, Canada, and other class action parties *fully satisfies* the Tribunal's compensation orders. A letter-decision is similar to an oral ruling from the bench and the Tribunal will release its full reasons in the coming months.

This landmark decision approving compensation recognizes the egregious harms flowing from Canada's wilful and reckless discrimination against First Nations children, youth, and families in its provision of child welfare service and failure to properly implement Jordan's Principle.

This letter-decision follows the Tribunal's order (2022 CHRT 41), finding that the class action FSA signed by Canada, the AFN and the class action parties in June 2022 did *not* fully satisfy its orders on compensation. To address the Tribunal's order, the AFN and Canada returned to the negotiating table with the new addition of the Caring Society to revise the FSA.

The Revised FSA addresses key issues raised by the

Tribunal in its 2022 CHRT 41 order, including ensuring that children and families entitled to compensation through the Tribunal orders but were left out of the class action FSA would receive compensation through the Revised FSA.


The Revised FSA will now be submitted to the Federal Court for final approval before steps

are taken to implement the Revised FSA and distribute compensation.

Meanwhile, work remains on the issue of long-term reform of the First Nations Child and Family Services program and the full implementation of Jordan's Principle to ensure the discrimination ends and does not reoccur.

#### SAVE THE DATE Orange Shirt Day/ National Day for Truth and Reconciliation is Coming Up!

Now in its tenth year, Orange Shirt Day was created by Phyllis Webstad who, in sharing her experiences

attending a residential school as a young child, spearheaded a movement for all people living in Canada to learn about the residential school system and its impacts, honour Survivors, their families, and the children who did not make it home, and take action in the spirit of truth and reconciliation.

The Caring Society is fortunate to partner once more with Assembly of Seven Generations and Beechwood Cemetery to host our third annual event for Orange Shirt Day and the National Day for Truth and Reconciliation on September 30. We have the following activities on this year's agenda:

- The unveiling of the Children's Sacred Forest and stone, honouring the First Nations, Métis, and Inuit children who passed away in residential schools;
- Reconciling History Walking Tours at Beechwood Cemetery where participants can visit the resting sites of prominent Canadians who were involved in the residential school system and learn more about the Truth and Reconciliation Commission Calls to Action;
- Showings of Spirit Bear's film Spirit Bear: Honouring Memories, Planting Dreams;
- Action tables where participants can write letters and make art detailing their commitment to reconciliation;
- Reconciling History Walking Tours throughout Downtown Ottawa, where
  participants can learn about the involvement of the federal government
  and non-Indigenous people in the residential school system and think
  about the lessons we can take from the past to address contemporary
  harms against First Nations, Inuit, and Métis peoples.

## The Spirit Bear Virtual School is Now Open!

On August 23, we launched the Spirit Bear Virtual School, a new online resource to support learning about the Caring Society's campaigns and initiatives for social justice and reconciliation. In response to research findings that said educators would benefit from resources designed specifically for teaching the Caring Society campaigns, the Caring Society, along with University of Ottawa researchers Drs. Lisa Howell and Nicholas Ng-A-Fook, created the Spirit Bear Virtual School and its resources. While these resources were specially designed for elementary educators, they are adaptable for older learners and accessible to everyone.

On the website, you will find *Spirit Bear's Beary Caring Curriculum*, which is grounded in five guiding principles known as the "Touchstones for Learning," adapted from the Touchstones of Hope reconciliation process of truth-telling, acknowledging, restoring, and relating. Another key resource is the *Jordan's Principle Learning Guide*, which invites everyone to learn about the human rights case on First Nations child welfare and Jordan's Principle, and to participate in ending discrimination against First Nations children and youth.

Along with many other resources and learning opportunities, the school offers video interviews with early years educators Dr. Michelle McKay and Klara Redford, who discuss their use of the Caring Society's campaigns and resources in their kindergarten classrooms, the enormous capacity young children have to understand love, fairness, and justice, and how learning about historical and ongoing injustices must start in kindergarten.
