## Federal Court Approves \$23.4 Billion Revised Compensation Final Settlement Agreement for First Nations Children, Youth and Families

On October 24, 2023, the Federal Court approved the \$23.4 billion Revised Final Settlement Agreement (FSA) on Compensation for First Nations children and families who experienced discrimination because of Canada's inequitable provision of the First Nations Child and Family Services program and flawed, narrow implementation of Jordan's Principle. The Federal Court's approval followed from the Canadian Human Rights Tribunal's (Tribunal) finding that the Revised FSA on Compensation satisfies the Tribunal's earlier orders on compensation.

While the Federal Court has approved the Revised FSA, there are still additional steps before any compensation will be paid to the victims. The Federal Court must first approve the Distribution Protocol, which sets out compensation eligibility criteria, procedures, the necessary forms to be filled out, and the supports for beneficiaries. Once the Distribution Protocol is approved, the application process will begin; this will likely be in the fall of 2024. Applications will be made to and decided by Deloitte LLP, the Administrator appointed by the Federal Court. The goal is to identify as many people who are eligible for compensation as possible, using existing records. Canada is preparing a database of all eligible children in care and from care that it can identify.

The Revised FSA also requires Canada to fund supports, like mental wellness, navigator, and application supports. While the Caring Society provided recommendations to class action parties about the types of supports needed, it is ultimately up

to the Assembly of First Nations and class action parties to adopt them.

The Caring Society's primary role in compensation was before the Tribunal, and we are not a party to the class action. The class action lawyers, alongside the committees they create, will take the lead

role on compensation implementation. The Caring Society has a limited role in compensation moving forward. While the Revised FSA is implemented, the Canadian Human Rights Tribunal continues to hold jurisdiction to ensure Canada's discrimination stops and does not happen again.

## **Orange Shirt Day 2023**

The Caring Society was so privileged to partner once more with Assembly of Seven Generations (A7G) and Beechwood Cemetery to host a number of reconciliation-based activities in honour of Orange Shirt Day. This year's agenda included the following activities:

- Reconciling History walking tours at Beechwood Cemetery and throughout Downtown Ottawa. Young people from A7G facilitated tours not only on September 30, but also on October 2, which was a recognized statutory holiday for federal public servants. The newly revised Downtown tours educated participants about the various historic and contemporary harms against First Nations, Métis, and Inuit communities, but also emphasized the many awesome things that communities are doing today, and how the residential school system is just one piece of an ever-evolving story.
- The unveiling of the Children's Sacred Forest at Beechwood Cemetery. At 2:15 pm on September 30, participants witnessed the unveiling of the Children's Sacred Forest and accompanying stone to honour the children who passed away at residential schools. Surrounded by baby pine trees (www.bit.ly/babypines) that will never grow past the height of a child, the stone is meant to serve as one of many places of honouring and remembrance.
- Showings of the newly released *Spirit Bear: Honouring Memories, Planting Dreams*. Attendees of all ages learned more about reconciliation by watching Spirit Bear's third big-screen adventure.
- Art and letter-writing at the Action Tables. Back again for another year, the Action Tables provided a space where people of all ages could demonstrate their commitment to reconciliation through art and letter-writing to elected officials, calling on them to fully implement the TRC Calls to Action.

## Cindy Blackstock Receives "Children's Nobel Prize"

In a vote determined by millions of children from around the globe, Dr. Cindy Blackstock was awarded the 2023 World's Children's Prize for the Rights of the Child, also referred to as the Children's Nobel Prize, for her role in the collective work to advance the rights of First Nations children, young people, and families. Previous recipients of the award include Nelson Mandela and Malala Yousafzai!

On October 4, Cindy was presented the award by Queen Silvia of Sweden at the ceremony in Stockholm, but her favourite part of the experience was getting to travel to local schools and spend time with the students. The Caring Society is thrilled that the movement for culturally based equity for First Nations children, young people, and families is being taken up by kids all over the world!

## Jordan's Principle Back-to-Basics Webinar

Implementation of Jordan's Principle has

improved; however, Canada still fails to fully implement it, resulting in delays and denials in services and supports for First Nations children. In addition, many people are still unclear about who is eligible, how to apply, and how to respond when they face barriers when applying for Jordan's Principle. On October 23, FNCARES and the Caring Society held a webinar to educate people about these issues and try to provide some strategies for overcoming barriers faced when applying for services and supports through Jordan's Principle.

Dr. Cindy Blackstock introduced the topic and context for the presentation, and then Dr. Helaina Gaspard from the Institute of Fiscal Studies and Democracy presented her research on Jordan's Principle and substantive equality. Dr. Gaspard also invited service providers and paediatricians to contribute to a new project designed to inform the development and implementation of solutions for achieving substantive equality.

Next up was Dr. Ryan Giroux, who presented findings from research by the Canadian Paediatric Society on paediatricians' knowledge, behaviour, and experiences of accessing Jordan's Principle for First Nations children and youth. Afterwards, Molly Rasmussen of the Caring Society presented on the Back-to-Basics Approach that Indigenous Services Canada staff are required to follow when they receive Jordan's Principle requests. Molly also described who is eligible for Jordan's Principle and provided strategies for overcoming barriers when submitting requests. Over 670 people registered for the webinar, demonstrating the need for more discussion and education about Jordan's Principle and the need to keep pushing Canada to fully implement Jordan's Principle, so that First Nations children get the services and supports they need without denial or delay.
